

## PRE-REG MEMBERSHIP

This is an open category that allows the GLDA to assist designers to further develop their Garden Design skills through classes, workshops and a mentoring programme tailored specifically towards the requirements for the portfolio assessment to gain Full membership over a clearly defined timescale.

GLDA's Pre-Registered Membership programme is based on established standards of excellence in garden/landscape design, and is intended to assist interested applicants to progress up the ladder towards applying for Full Membership status. Pre-Registered Membership is an affirmation of your knowledge and skills as a competent designer with growing credentials.

Annual Pre-Reg Membership costs **€120 per annum**, payable in March each year. Applications received part-way through the year will be charged on a pro-rata basis for that year.

### Eligibility:

- Be an established garden/landscape designer in good standing, who is currently a Friend or Overseas Friend of the GLDA. Your status as a Friend will continue until your application for Pre-Registration Membership has been approved by the GLDA Membership Assessment Panel (MAP).
- Be a recently qualified student of garden/landscape design. Course material covered should include residential landscape design, landscape drawing, plant materials, landscape construction and maintenance with an emphasis on the design process.
- Have a background in design, art or other creative discipline and be considering a new career in garden and landscape design.

### The benefits of Pre-Registered Membership are:

- Educational needs checklist and CPD advice on website
- Portfolio development workshops
